Dear Colleagues,

Last month we shared a link to an article about nurses making changes to their practice to improve patient handovers. There are many things that nurses and technologists can do together or within their own professional teams to practice at the full extent of their roles. Many experts have commented that outcomes for patients are best when all team members are functioning to their full legal professional scope. Environments where staff have control over their practice and how it is shaped can also lead to improved morale and retention. Working within larger teams particularly in highly structured health care settings where there can be many regulations and process steps that govern how staff can evolve and grow their roles to enhance patient care can be challenging. However, there are many great examples, such as team handovers, communication tools, establishing regular assessment days such as "socks off days" on units that staff can implement to enhance patient care without requiring extra resources or inter-dependency on other professional groups.

A further example was presented in the January/February edition of the Canadian Nurse (Vol. 113 No.1 page 14, the CNA discusses the development of the first nursing list for Choosing Wisely Canada including Nine Things Nurses and Patients Should Question, among them: "2. Don't advise on routine self- monitoring of blood glucose between appointments for clients with diabetes who do not require insulin." I am curious about what kinds of things are happening in the practice environments of our members around advancing scope and roles. What kinds of things do nephrology nurses and technologists feel should be part of their roles and aren't? Are there any good news stories that you would like to share about initiatives in your practice setting developed by nurses and/or technologists that have lead to successful improvements for patients and staff on your unit?
