DUTIES AND RESPONSIBILITIES:

Reporting to the Patient Care Manager, the Unit Coordinator is responsible for the coordination of patient assignment at LHO, chair allocation for patients in collaboration with LHO, coordination of nursing, staff and resources on all shifts, facilitating patient flow, and acting as a steward for developing and facilitating the family-centred approach within Ambulatory In-Centre Hemodialysis.

The Unit Coordinator will also assist in the support of any required data collection with the Data Lead, focused on data collection related to COVID (patient tracker) as per requirements of the Ontario Renal Network, to maintain data accountability in the Ontario Renal Reporting System and ORRS.
